The **Conservative ETF Composite** includes fully discretionary portfolios that invest in U.S. stocks that are considered to have superior value creation prospects relative to that of the average company within the benchmark, 20% Russell 1000® Index, 45% FTSE US Broad Investment-Grade Bond Index (USBIG®), 35% FTSE USBIG Treasury (3-7 Yr)®. The benchmark is rebalanced monthly, with the blended return geometrically linked to calculate quarterly and annual returns.

SWS Partners, LLC (“SWS”) claims compliance with Global Investment Performance Standards (GIPS®) and has prepared and presented this report in compliance with the GIPS standards. SWS has been independently verified for the period July 1st, 2017 through December 31, 2022 . A firm that claims compliance with the GIPS standards must establish policies and procedures for complying with all the applicable requirements of the GIPS standards. The annual composite dispersion presented is an asset-weighted standard deviation calculated for the accounts in the composite the entire year. The trailing three year annualized ex-post standard deviation for the Composite and Benchmark are calculated using gross returns. Conservative ETF Composite inception is August 1st, 2017.
